2. Site plan with location or improvement drawn to scale. Note distance from property lines. Show relationship of improvement to neighboring homes and/or open spaces.
3. Drawings and/or illustrations showing design of proposed improvement- state architectural style of existing house.
4. Scale drawing of exact dimensions of improvement.
5. Type of wood or other materials to be used.
6. Color: note whether color is same as existing siding or trim on house or attach color chip for other color/stains.
7. Grading plan if changes in grade or other conditions adversely affecting drainage are anticipated (generally, approval will be denied if adjoining properties are adversely affected by changes in drainage).
8. Landscape plan if application is for landscaping or if relevant to project.
9. Signed written agreement of affected lot owner if improvement falls on property line.

Acknowledgement of Applicant:

1. I understand that construction of certain major projects requires that I obtain a King County building permit. Approval of a project by the ARC does not affect or alter that requirement.
2. I understand that any construction activity taken prior to ARC approval is not allowed and that, if alterations are made, I may be required to return the property to its former condition at my own expense if this application is not approved wholly or in part, and that I may be required to pay all legal expenses incurred if legal action becomes necessary.
3. I understand that members of the Architectural Review Committee are permitted to enter on my property to make reasonable inspection of proposed construction locations.
4. It is understood that I am aware of the Covenants, Conditions and Restrictions and Architectural Controls with regard to the review process.
5. The alteration authority granted by this application will be revoked automatically if the alteration requested has not commenced within six months of the approval date of this application and/or has not been substantially completed within twelve months.
6. I understand that any approval is contingent upon construction or alterations being completed in a workman-like manner.
7. I understand that if I disagree with the ARC ruling, an appeals procedure is provided directly through the Board of Directors.
